We are forwarding herewith Notification No. 37/2016-Customs dated June 16, 2016 issued by Government of India, Ministry of Finance, (Department of Revenue), New Delhi

We inform you that vide Notification No. 27/2011-Customs dated March 1, 2011 SI.No.9A and the entries relating to has been omitted.

Further vide Notification No. 15/2013-Customs dated March 1, 2013 SI.No.9A inserted as under:

"9A	1701	Raw sugar, white or refined sugar	NIL"
-----	------	-----------------------------------	------

Prior to this, as per second schedule of the Customs Tariff Act, 1975, the entry was as follows:

9A	1701	Raw sugar, white or refined sugar	20%
----	------	-----------------------------------	-----

It concludes that vide Notification No. 37/2016-Customs the entry in the Notification No. 27/2011-Customs has been omitted, therefore export of sugar would attract customs duty @ 20% with immediate effect.
